1.0 SPECIFIC REQUIREMENTS.

1.1 Location of Work: The work will be performed at Gig Harbor, Washington.

1.2 Period of Performance: The period of performance is 60 calendar days from contract award. This includes the completion of work contained in this Performance Work Statement for the base contract line items. Period of performance for the optional line items will include the solicitation, award and performance of the construction contract.

2.0 SCOPE OF WORK

The purpose of this work statement is to obtain Construction Management (CM) Services in accordance with General Service Administration (GSA) Federal Supply Schedule (FSS) Special Item Number (SIN) 871-7 to provide construction management services to construct a leveled 300 Sq. Ft. (15 x 20), heated (propane or electric, efficient) as specified to greenhouse sq. footage, corrugated Polycarbonate for greenhouse specific of medium grade; 1 to 2 ea. 36 wide glass/screen entrance door(s), interior walkway surface hard enough to support wheeled devices (2000 PSI), manually vented Greenhouse. Interior metal or wood counter top/planter beds to meet ADA interior space requirements. Indoor lighting as required to see. One ea. water accessible hose bib service within Greenhouse, 48" above ground. Water pipe constructed of PVC. One electrical, 110V outlet. Ramped at thresholds, if needed. Able to withstand wind gusts in the area. Services to be located in Gig Harbor, Washington. The Department of Veterans Affairs (VA), Vocational Rehabilitation and Employment Division (VR&E) has approved the Veteran for the Independent Living Program (ILP), which includes residential construction alterations. 2.1 Construction Project Objective: To provide for accessible year-round gardening avocational activity. The intent of this project is to construct an alternate greenhouse of similar scale and size; however, sized for ADA standards, to be used as avocational in nature, residential and not for commercial use, to replace greenhouse that is not ADA compliant, allowing the Veteran ADA access for his gardening avocational activities. The greenhouse should have a climate control system and to regulate the temperature in extreme conditions. The walkway leading to the structure should be evaluated to ensure ADA compliance is maintained.

2.2 Sustainability Objectives: The VA requires that all construction projects be accomplished with sustainable design and construction elements incorporated. The construction contract (please reference the IL Construction PWS Template provided by the Contracting Officer) will contain language requiring waste management plans, the use of energy efficient, water efficient, and recycled content equipment and products. The required deliverables under this PWS shall incorporate, to the maximum extent practicable, these ideals and objectives.
