Please understand I am not pissing on your parade of facts. I am trying to teach you how to fight fire with fire. All I would ask is that if your techniques are so successful, why all this discussion and assembly of photos/buddy letters etc. to win? Take a poll. Currently, you can still buy a great herbicide called Spectricide at Wilco. It's prime ingredient is- hold on to your hats- 2,4-D. I use it to control tansy ragwort in my pastures which is poisonous to my horses. 2,4,5-T, on the other hand, is no longer produced commercially. The problem is not either chemical combination but the combining of the two. They produce a third unintended carcinogenic chemical (dioxin) which causes all the problems we suffer. 2,4,5-T has also been proven to have deleterious (carcinogenic) effects on laboratory animals all by itself which precludes its use these days.

You can call an herbicide a brushkiller, a soil sterilizer or whatever you choose. That, in and of itself, is a generic term. The VA recognizes only that we used a "commercial herbicide" aka tactical herbicide aka brushkiller in Thailand. Nowhere will you see it admitted on paper that the US Military sprayed AO, AB, or any other rainbow herbicide in Thailand. How difficult is that to absorb? I don't wish to be redundant, but it seems you are clinging to wishful misinterpretation of what is printed in plain English. Mr. McCay reads "presumptive" where it is nowhere written. You read "herbicide agent" where it is nowhere documented in contemporary reports on the subject.

I have no doubt, personally, that AO or AW or AB were used in Thailand. Can I prove it? No. I don't need to. All I need is a nexus letter from a MD saying it is "at least as likely as not" that the tactical herbicides caused IHD, Parkinson's DM II etc. End of discussion. Game. Set. Match.

I don't wish to insult any of you but if I didn't know any better, I'd think some of you are charter members of the Flat Earth Society. Wishful thinking is not a viable litigation technique when presenting a claim before the VA. You are allowed to testify about what comes to you via your five senses-period. Unless you have an MD or other suitable medical degree that allows you to opine on medical matters, your testimony is not accepted by VA. Hence, the use of nexus letters. Unless, or until VA and Congress change the statute and regulation, we are stuck with this poker hand. Would you hitch your horses to a plow if you had a gas-powered, self-propelled riding rototiller? I'm beginning to wonder...
