**INTRODUCTION**

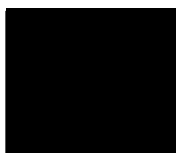
The records reflect that you are a Veteran of the Gulf War Era, Peacetime and Vietnam Era. You served in the Army from May 25, 1972 to January 28, 1979 and the Air Force from December 20, 1990 to July 1, 1991 and from October 15, 2000 to March 3, 2001. The Board of Veterans Appeals made their decision on your appeal on May 31, 2022. We have implemented their decision based on the evidence listed below.

**DECISION**

Service connection for hepatitis C with residuals to include advanced liver disease/F4 fibrosis is granted with an evaluation of 0 percent effective September 16, 2019.

### **REASONS FOR DECISION**

#### **Service connection for hepatitis C with residuals to include advanced liver disease/F4 fibrosis.**

On May 31, 2022, the Board of Veterans Appeals issued a decision on your pending appeal. This decision merely implements the decision administered by the Board of Veterans Appeals. Please see the decision of May 31, 2022 for additional details and information regarding their decision.

Service connection for hepatitis C with residuals to include advanced liver disease/F4 fibrosis has been established as directly related to military service. (38 CFR 3.303, 38 CFR 3.304)

An evaluation of 0 percent is assigned from September 16, 2019, the date VA received your intent to file for compensation. (38 CFR 3.155, 38 CFR 3.400, 38 CFR 3.2500)

In assigning the evaluation, VA treatment records were reviewed and considered alongside VA examinations of December 11, 2019, and June 11, 2020. Both VA examinations noted the diagnosis of hepatitis C, resolved, with F4 fibrosis without cirrhosis, confirmed by CT scan in

2017. You have had a negative viral load since 2016. No further treatment has been necessary. Although symptoms of fatigue and upper quadrant pain were subjectively reported after the examination, it was initially reported that there were no symptoms regarding the diagnosis of hepatitis-C. When VA treatment records were reviewed, there were no reports of fatigue nor upper quadrant pain related to the diagnosed condition. No incapacitating episodes are objectively noted on VA examination or found within VA treatment records. No malaise or nausea is found. The examiner noted that fatigue is a routine symptom of active hepatitis-C and again, your diagnosed hepatitis-C has resolved.

We have assigned a noncompensable evaluation for your hepatitis C to include advanced liver disease/ F4 fibrosis based on:

- Nonsymptomatic (38 CFR 4.31)

A higher evaluation of 10 percent is not warranted for hepatitis C unless the evidence shows:

- Intermittent fatigue, malaise, and anorexia or incapacitating episodes (with symptoms such as fatigue, malaise, nausea, vomiting, anorexia, arthralgia, and right upper quadrant pain) having a total duration of at least one week, but less than two weeks, during the past 12-month period. (38 CFR 4.114)

A noncompensable evaluation is assigned unless there is some disabling interference with digestion. (38 CFR 4.114)
